## **Terms of Sale**

By signing this Contract, Adopter and Breeder agree to the following:

## **BREEDER:**

- 1. Kitten is healthy to the best of the breeder's knowledge, has had all of the age appropriate vaccinations and wormings and is free of all internal and external parasites as confirmed by a licensed veterinarian at the time of adoption.
- 2. Breeder will provide a pet record from a licensed veterinarian listing all vaccinations, wormings, treatments (if any) and the dates thus far.
- 3. The breeder guarantees for **ONE YEAR** that if a fatal defect occurs as a result of a genetic or congenital defect the breeder will replace the kitten (less shipping charges and veterinary expenses). A histopathology/necropsy report (at buyer's expense) from a licensed, board certified veterinarian is absolutely required.
- 4. Viral diseases (including Feline Infectious Peritonitis or FIP), parasites or bacterial infections are not covered by this health guarantee.
- 5. Breeder does not warranty the cat/kitten from any adverse reactions against future vaccinations or any other procedures/surgery performed on the cat/kitten including spay/neuter.
- 6. The kitten(s) will be registered with The International Cat Association (TICA) as a breeding or non-breeding kitten depending on the agreement between the breeder and adopted.

## ADOPTER:

- 1. These are strictly indoor cats only. DO NOT ever expose to unknown outdoor cats/animals. Allowing your kitten outdoors where it may be exposed to diseases, fleas, ticks, and parasites, voids the health guarantee.
- 2. Adopter is responsible for ALL veterinary expenses incurred after acquiring kitten(s).

- 3. Adopter will ensure that the kitten has the recommended routine vaccinations and wormings to maintain the health of the kitten. I recommend only the Purevax Rabies vaccination and for purebred felines.
- 4. All warranties are VOID if the kitten is given an FIP, Feline Leukemia vaccines. RABIES can't be given in combination with any other vaccines; they MUST be spaced out at least 8 weeks, MERIAL brand is highly recommended. Don't give any 4-way vaccinations only 3 way! Combining vaccinations or declaw voids the warranty.
- 5. Adopter agrees to have the kitten spayed/neutered between 5-6 months and no sooner. If done sooner the one year guaranteed will be revoked.
- 6. Written proof of the spay/neuter from your veterinarian is required if you want registration papers for your kitten(s).
- 7. If the breeder does not receive proof of the spay/neuter prior to the kitten reaching 7 months of age, TICA registration will be destroyed and the one-year health guarantee will be revoked.
- 8. It is your choice whether or not you want to have your kitten tested for the feline leukemia and this is at your expense.
- 9. Breeder has no control of and assumes no responsibility for the Adopter's allergies to cats, affect or injury in relation to kitten's behavior, affect or injury by other pets, disapproval by landlord, lack of proper training by Adopter, lack of proper nutrition or care by adopter or unpredictable features of the kitten as it matures into an adult, such as physical size, length of fur, coloring or behavior of the kitten.
- 10. If you should no longer be able to keep your kitten, we will work with you to help you find a suitable home. No refunds will be issued if you are not able to keep your kitten. Kitten is not to be sold under any circumstances. If kitten is found to have been sold or given away, the health guarantee is void and is not transferrable.
- 11. Breeding of any unaltered 2 Queen's and a King Ragdoll without breeding rights is strictly prohibited. Breeder may elect to proceed with legal action if it is discovered that the adopter is breeding a 2 Queen's and a King Ragdoll. All legal proceedings will take place within County and State of Breeder's residence. Howard County, Iowa.
- 12. If adopter violates any of the terms of this contract breeder has the right to recover the kitten(s) and adopter will comply by returning kitten(s) to breeder with NO REFUND/REIMBURSEMENT.
